#### 10.2 New General Business

#### 1. Public Art Policies

Cr Harley requested an update on the guidelines that Officers use in determining the recommendation to purchase public art being considered for approval by the Finance and Administration Committee.

The Acting Director Economic Development advised that the Policies are Council Policy 18.1 – Arts and Culture and 18.2 – Cultural Collections and will both be reviewed as part of the Arts, Culture and Heritage review. An update and copies of these policies will be provided to the Finance and Administration Committee.

# 2. Cycles available in Car Parks

Cr Chen queried the lack of use of cycle lanes in the city and whether the City could look into providing bicycle hire facilities within the City's car parks. Cr Harley suggested investigating whether a private business could provide the bike hire facilities and if the City could consider providing the physical space within the City car parks as an added service for patrons.

The Chief Executive Officer advised that this has been considered in the past, however, the Administration can reconsider this initiative and provide some information back to the Finance and Administration Committee.

#### 3. Property Council WA

Cr Chen queried whether investigations or discussions have been had with the Property Council of WA in relation to development methods or ways to tackle vacant commercial office spaces within the city to transform them into residential apartments. The Chief Executive Officer advised that there is currently two outstanding items in the Finance and Administration Committee agenda in relation to this that will be provided to the next Planning Committee.

## 4. Loading Bays

Cr Harley queried an article that was raised in the West in relation to amended regulations for parking in loading bays and a number of complaints received in relation to this and whether it had been appropriately communicated to the community.

The Director Community and Commercial Services advised that there has been no changes to parking regulations and that it is enforcement of the local law in ensuring that the loading bays are available for unloading of goods to facilitate freight throughout the city. The City will continue to communicate this.
