Purpose and Background:

This report presents feedback from the stakeholder consultation received during the consultation which occurred between December 2016 and May 2017, and details the Wellington Square Enhancement Framework and the proposed next steps in the development of the Masterplan.


Details:

Stakeholder and community participation in the development of the Wellington Square Masterplan has been identified as critical to achieving the best outcome for the project.

As well as a detailed analysis of the site, the Framework for Wellington Square has been informed by feedback and comments received via a range of activities since December 2016, including:

- Stakeholder workshop;
- On-line Survey (via EngagePerth.wa.gov.au);
- ‘Map it’ planning tool (via EngagePerth.wa.gov.au); and
- Cultural Heritage Assessment.

An online survey was launched on 7 December 2016 and made available via the City’s online platform, Engage Perth. Residents and businesses within a 400 metre radius were directly informed of the survey via a letter drop. A total number of 212 responses were received at the close of the survey on 23 December 2016. The intent of the survey was to capture how the park is currently used and the community’s future aspirations for the space.



Common issues raised in the responses included:

- Safety when using the park;
- Limited opportunities for active recreation;
- Lack of community facilities e.g. enhanced playground, barbecues;
- Lack of temporary or permanent cultural activity; and
- Lack of Noongar interpretative representation.

The top priorities (ranked in order) were:

1. Recreation;
2. Nature;
3. Socialising; and
4. Heritage and history

A stakeholder workshop with representatives from Local and State Government Agencies, City of Perth staff, community, social services and organised sports groups was held on 8 December 2016.

Issues around safety and security surfaced as the single major topic of concern. The group also identified that the lack of community facilities was one of the main contributors to the under-utilisation of Wellington Square.

Cultural Heritage Assessment

A vital part of the Cultural Heritage Assessment was the engagement of the Whadjuk Working Party (WWP) in April 2017. Stakeholders identified a number of key priorities for the rejuvenation of Wellington Square including:

- Maintaining Wellington Square's integrity as a social and meeting place;
- Recognition of the cultural significance of Wellington Square: meeting place and 'Kids Tree' (large Moreton Bay Fig located on the northern side of the park);
- Recognition of Noongar people's long history and association with the area;
- Improve facilities including the installation of a new playground;
- Improve access and safety;
- The cultural values of Wellington Square are considered and incorporated into the Masterplan and the WWP are further consulted about design plans for the enhancement project; and

- An interpretation plan for Wellington Square is developed in collaboration and guidance of the WWP.

Framework

The consultation to date has highlighted the community's desire for a range of leisure, cultural and celebratory activities in Wellington Square. The Framework provides a high level plan to inform the future use of Wellington Square and the final Masterplan.

Key aspects of the Framework include:

- Balancing active and passive recreational needs;
- Accommodating formal sports;
- Identifying pedestrian desire lines and main routes;
- Identifying a hierarchy of entry points and connections;
- Identifying a pedestrian priority zone to the north of the park;
- Maintaining a meeting place; and
- Addressing the edges of the park.

The following principles underpin this Framework:

Treasure:

- Treasure our community;
- Treasure the cultural heritage of the park; and
- Conserve and protect what is special about the place.

Connect:

- People; accessibility, mobility and social;
- Environment; city ecological services; and
- Place; surrounding neighbourhood.

Enjoy:

- Safe, comfortable, inviting and fun;
- Enhance health and wellbeing; and
- Provide for a range of uses at overlapping times of the day.

Utilise:

- optimise environmental and economic benefits; and
- use resources efficiently.

Financial Implications:

There are no direct financial implications with this Report.

There will be financial implications associated with the adoption of the final Masterplan and the associated implementation plan.

Comments:

Several consultation activities for the Framework are planned in the coming months to build on the initial feedback and ensure continued stakeholder and community participation in the Masterplan process.

These include:

- Social media updates;
- Establishment of a Community Reference Group;
- Community Visioning Day (on site activation);
- Digital engagement via Engage Perth;
- ‘Map it’ tool;
- Brainstorm, Guest Book and Forum functions;
- Letter/flyer drops to surrounding areas;
- Stakeholder Workshop; and
- Media relations (to raise awareness of engagement activities).

The feedback generated during these activities will be consolidated into a report, which will be referenced by the project team during further refinement of the draft Masterplan for Wellington Square.



Purpose and Background:

In June 2008, the State of Western Australia and the City of Perth signed the Link Project Implementation Deed (the Deed). Under Clause 3.3(b)(iii) of the Deed, the City of Perth accepted responsibility for funding and coordinating the upgrade of Roe Street, between Fitzgerald Street and William Street. The works were to be completed within six months of the date of practical completion of the sinking of the railway, west of the Horseshoe Bridge.

Detailed design work on the adopted Roe Street Enhancement Masterplan commenced in 2012, however the Metropolitan Redevelopment Authority (MRA) requested that the project be put on hold. At this time, the MRA and the City agreed that construction on Roe Street and associated lane closures would cause unacceptable disruption and impede access during construction of the new underground Wellington Street Bus Station, Yagan Square and Wellington Street enhancement.

With Yagan Square, King Street extension and Wellington Street due to be completed in late 2017, the City has worked with the MRA to reschedule the project for 2018.

The Roe Street Masterplan was originally designed to accommodate a future light rail line on Roe Street between Fitzgerald Street and Yagan Square. However the latest plans for the light rail network (Department of Transport's *Perth and Peel Transport Plan – Transport at 3.5 Million*, February 2017) does not include a northern arm. The Masterplan has been revised in light of this, and has been extended to include Roe Street between William and Beaufort Streets.

This report provides details on the revised Masterplan including estimated costs and a proposed construction program, along with the results of the public consultation on the proposal.

Details:

The Masterplan provides a high-level framework for the detailed design of Roe Street.

Design Principles

The 2012 Roe Street Masterplan was developed based on the following key principles and objectives:

- raise the profile of Roe Street to stimulate economic vitality in the area;
- improve access and amenity for pedestrians and cyclists while accommodating existing traffic;
- improve the aesthetics and ambience of the street for the increasing number of residents and workers in the area;
- provide new street furniture, lighting and street planting;
- retain kerbside services; and
- provide Universal Access, ensuring compliance with applicable standards.

Revised Masterplan

As the Department of Transport no longer has plans for light rail on Roe Street, the Masterplan was revised to create:

- a narrower street carriageway, to encourage lower vehicle speeds and make it easier for pedestrians to cross. (The road reserve will not be narrowed so Roe Street can accommodate light rail in the future if required);
- wider footpaths to accommodate increased pedestrian numbers and activity including alfresco dining (this is particularly significant west of King Street where only 1.5 metre wide footpaths were previously possible);
- a wider protected dedicated bike path to accommodate the already large number of cyclists using this popular route; and
- additional street trees, particularly in the underground-service-congested northern verge (by widening the footpaths trees are now possible, subject to further investigations).

The key components of the revised Masterplan (Attachment 6.2A) are:

Perth Cultural Centre Strategic Framework

The Office of the Government Architect is developing a Perth Cultural Centre Strategic Framework which includes plans to improve the ground level interface between the precinct and Roe Street. Proposed Roe Street enhancements, such as wider footpaths and shade trees, will support the increased pedestrian activity likely to be generated by the Cultural Centre revitalisation.

Traffic Implications

Traffic analysis of the proposal has confirmed the removal of clearways will have a minimal impact on the operation of the city's road network and that key intersections along Roe Street will continue to operate well within capacity.

Public Consultation

The revised Masterplan was published on the City's community engagement website 'Engage Perth' in July 2017 and details of the proposal were sent to:

- all property owners, tenants and businesses within the area defined on the 'Focused Consultation Map' (Attachment 6.2B); and
- relevant State Government agencies, disability groups, transport bodies and industry bodies.

Of the 15 formal responses received:

- six were fully supportive of the proposal;
- seven provided conditional support; and
- two were neutral.

In general, comments were supportive of providing a more pedestrian-friendly, cycle-friendly street environment.

The Masterplan has been updated to incorporate comments from the consultation, including widening kerb ramps for bicycle access and increasing storage space for cyclists at the William Streets intersection. Changes were also made to the median between Beaufort and William Streets to ensure unrestricted access and movements to and from car parks.

During the detailed design phase there will be additional stakeholder consultation to ensure that the requirements of internal and external stakeholders are appropriately addressed. Cross-overs to future Perth City Link developments will also be accommodated in the detailed plans.

Attachment 6.2B provides a full account of the consultation responses.

The current budget is for design documentation and project management. A further budget of \$12,300,000 has been allocated in the 10 Year Capital Works Plan for financial years 2018/19 and 2019/20. This budget was based on the 2012 Masterplan scope (Fitzgerald to William Street) and did not account for escalation of costs.

Estimated Construction Cost

An independent quantity surveyor has estimated the construction cost at \$15,442,000 including a 20% contingency for unforeseen construction costs and escalation to mid-2018. This estimate is based on the revised Masterplan and as the detail of the design is yet to be resolved, this cost estimate should be considered as being within +/- 30% accuracy.

Asset Write-Off Implications and Life Cycle Cost

The total asset disposal value for the Roe Street Enhancement is \$1,162,870.

The project is significant in size (one kilometre long) and includes existing assets that are in various stages of their lifecycle. Some assets do not require replacement for many years and others are approaching the end of their useful life. Consequently some assets will be replaced before reaching their full economic value.

While the estimated annual maintenance costs over the life expectancy of the assets is not provided in this report, the City's standard material palette will be used and therefore the life cycle cost of this project is consistent with current asset expectations.

Program

Construction is scheduled to commence in late 2018 and is expected to be completed by mid-2019.


The streetscape enhancement works will commence following underground service installations in Roe Street by the Water Corporation, Western Power and the MRA, planned for mid-2018. The City will coordinate with these agencies to minimise construction time, costs and disruption to adjacent businesses and the general public.






Roe Street Enhancement - Revised Masterplan - Public Consultation



Purpose and Background:

This tender was advertised as Tender **164 16/17 Tree Maintenance Services**, in the West Australian on Wednesday 17 May 2017. Tenders closed at 2.00pm, on Thursday 8 June 2017 with the following submissions received:

- Tree Care WA; and
- Classic Tree Services

This report assesses the two submissions and makes a recommendation.

Details:

This tender covers the tree management services associated with the City's street and parks trees. Street trees are typically pruned each year to maintain adequate clearances for pedestrian and vehicle traffic and to ensure trees remain clear of buildings (complete prune). The tender also covers unscheduled pruning to address storm damage, dead-wood in trees and to address other safety issues. Expert arboricultural assessments and/or analysis of tree structure and/or tree health are also included in this tender.

As part of their submission, companies were required to address the selection criteria set out in the tender specification and provide a fixed price schedule of rates across categories associated with the works and services to be provided.

Submissions were assessed against the following qualitative selection criteria:

- Relevant experience in completing similar works;
- Skills and experience of staff undertaking the specified works;
- Relevant resources including plant and equipment are detailed and available when required;
- Demonstrated understanding of the required works; and
- Tendered rates.

Assessment:

Classic Tree Services

The submission by Classic Tree Services received higher scores in all of the qualitative selection criteria. Classic Tree Services demonstrated a good understanding of the works required, particularly when applied to a Capital City situation with high traffic volumes and the high level of service expected by the City's customers. The tender submission provided sound methodology and evidence to support their claim of having highly skilled and qualified staff, with sufficient resources to undertake this contract. Of the 88 individual price per tree

scenarios sought in this tender 66 of the prices provided by Classic Tree Services were considerably less than the prices submitted in the tender by Tree Care WA.

Tree Care WA

The submission by Tree Care WA received lower scores in all of the qualitative selection criteria. Tree Care WA received lower scores in demonstrating their relevant experience in fulfilling similar contracts, the skills and qualifications of their staff, and their demonstrated understanding of the scope of this contract.

66 of the 88 individual price per tree rates provided in the schedule of rates are more expensive than the competitor's rates.

Comments:

The schedule of rates requested in this tender has been revised from previous years to reflect the variation in tree height. Previously the schedule of rates was limited to the types of pruning for a tree with no consideration of tree height therefore the cost to prune each tree to a similar standard was the same. A direct comparison of the rates in this tender with previous years is therefore not possible. However, a comparison of the prices submitted in each tender against the eight most common pruning activities and against a consistent number of trees resulted in an annual cost of \$591,900 by Classic Trees and \$1,072,740 by Tree Care WA.

Classic Tree Services' submission addresses the required selection criteria and is considered by the tender evaluation panel as the best offer for the City of Perth. Therefore it is recommended that Classic Tree Services be awarded the contract **164 16/17 Tree Maintenance Services.**

Purpose and Background:

The City of Perth city wide Close Circuit Television (CCTV) surveillance system plays a crucial role in the observation and management of activities occurring within and adjacent to the areas provided with camera coverage. It is imperative that the existing CCTV system (and associated equipment and devices) remain operational at all times. The maintenance works carried out as a part of this contract are required to ensure that all component parts are functioning correctly and that minimum down-time occurs in the event of any system fault, failure and/or disconnection.

The scope of work for this contract comprises of preventative maintenance works and breakdown repair service, including the supply, installation, programming, adjustment, calibration, testing and commissioning of specified equipment required to maintain and rectify fault occurrences associated with the CCTV system, devices and equipment detailed in the tender documentation.

The work includes the ongoing regular preventative maintenance and breakdown repair service for those installed systems which are not subject to third party maintenance/warranty as part of any contractual defect liability provisions.

Details:

Advertisements requesting tender submissions for the CCTV maintenance contract were lodged on Wednesday 28 June 2017 with an advertised closing date set at 5pm on Thursday 20 July 2017. Two responses were submitted and duly processed for compliance and qualitative assessment against the selection criteria.

Intervid – Powerstart Nominees Pty Ltd

The panel considered that Intervid's submission did not provide sufficient relevant information to receive compliant scores against any of the selection criteria. The panel considered that one criterion, 'Tenderers are to demonstrate an understanding of the management, administration and service provision to a Major City Council,' was not addressed.

Dataline Visual Link Pty Ltd (DVL)

DVL met all selection criteria with no deficiencies, exceeding criterion in 'Tenderers are to demonstrate an understanding of the management, administration and service provision to a Major City Council' and 'Demonstrate experience on installation and maintenance of Geutebruck systems in public area surveillance'.

DVL presented a thorough and comprehensive submission that clearly demonstrates their understanding of the tender requirements and their ability to manage the contract. DVL have conducted maintenance of the City of Perth CCTV system for the last two years and are experienced and qualified in the Geutebruck system having also completed multiple City of Perth CCTV projects during this period.

Comments:

When evaluating the tender responses, the panel took into consideration the responses to the selection criteria as well as the pricing options.

DVL demonstrated a better understanding of service provision to a capital city as well as demonstrating greater experience in maintenance of the Geutebruck CCTV systems. DVL also demonstrated a greater capacity to respond and resolve issues that may arise with the CCTV system. DVL's past performance as the incumbent CCTV maintenance contractor also validates their capacity to perform.

While the initial call out fee for DVL is slightly higher, the panel consider that DVL will provide better value for money over the life of the contract.
