# <u>Event Grants – Round 1 Summary</u>

- 16 eligible applications were received
- 7 applications were new and not previously funded
- A total of **\$421,402** in funding was requested
- Indicative budget of \$170,000 for Round 1
- Assessment panel of 4 assessed each application and scored against the criteria
- Applications are then ranked from highest to lowest scoring
