The Lord Mayor made the following announcements:

It was only a week ago we were in this Chamber to elect the Deputy Lord Mayor, and I'm delighted that in the time since the new Council have had opportunity to attend a number of briefings and meet with the senior Administration staff. Council has also had the opportunity to reaffirm our commitment and priorities.

Our top priority remains finding the right way for the City of Perth to play an active role in helping people who are homeless. It's a shared responsibility, but it is not a responsibility we intend to shirk. It is an issue I hope to raise with the Premier tomorrow.

On that, I'd like to thank Councillors Gobbert, Bevan, Fleeton and Ko who last night joined with the City's CEO and General Manager Community Development for the rough sleeper count. You are to be commended for doing your bit and stepping up. That is exactly the kind of leadership and commitment that we want our City of Perth to be known for.

There's a terrific spirit and unity developing within our group already, and it's a privilege for us to be here to serve the residents, ratepayers and other key stakeholders of the City of Perth. It is a responsibility we are all relishing.

Yesterday, I gave a Notice of Motion for consideration at the next Ordinary Council Meeting to provide free parking across City carparks in December 2020 and January 2021. It's been a challenging year for all West Australians, and the Council is in full agreement that we need to support our community, residents, city businesses and visitors in celebrating Christmas. We want to help revitalise our city and invite everyone to visit. Three-hours free parking is just one initiative to celebrate our city.

- Q1 How the assessment was conducted, as to who got grants and who didn't?
- Q2 Who made the assessment scorecard?

A General Manager Community Development:

The assessment is undertaken against the assessment criteria associated with that grant program. The criteria are outline in the attachment for each Item. The criteria are assessed by a panel of staff, currently consisting of four people. Staff are from the Economic Development unit, Activities Approval area, Urban Design area, and Planning. The panel members independently rate the applications against the criteria. The rating is then averaged across the panel members, and all applications then ranked highest to lowest. The amount of budget allocated does determine the percentage of against which the Administration decides whether an application is approved or declined.

Questions and responses

Deputy Lord Mayor Anghie

- Q1 What changes, if any, were conveyed to design considering the announcement of the Perth City Deal in September 2020?
- Q2 If there are changes to be made, what are the budget implications?
- A General Manager Infrastructure and Operations:

No changes have been made to date. The Administration has had meeting with Main Roads WA, the Department of Transport and DevelopmentWA regarding pros and cons of any change that might be made.

These agencies do not believe any changes are needed in the short term. The pro of getting the project started outweighs the cons.

This project being partially funded in the Perth City Deal, Administration is meeting with ECU shortly and will work out with them if there are any specific changes that make sense.

Any changes can be included in the detailed design due at the end of December 2020, or into the construction program works.

Councillor Bain

- Q1 Would there be any financial implications for the City if Council deferred decision-making to a later date?
- A Project Director Strategic Finance (CFO):

The financial implications of this project are such that we have prudently provided around half the cost of the money in a cash-back reserve now, and with the addition of the \$10million grant funding – which comes through the Perth City Deal – the project is essentially fully funded at this stage.

If the project were not to proceed at this time, then the potential financial implication could be failure to complete the obligations that come with the \$10million grant funding.

- Q2 Where's the trigger point where our contract may be in breach?
- A General Manager Infrastructure and Operations:

Clarification was sought whether the intent is to understand if there is a financial implication if the Council deferred the project from the point of view of:

 The tender being delayed, and therefore there being extra costs from the contractor for delaying the project?

OR

From potentially missing out on the Perth City Deal funding?

A Councillor Bain:

It was in relation to the Perth City Deal funding. Having raised the tender issue, an answer to both questions is requested.

A General Manager Infrastructure and Operations:

There is no indication at this point from the Department of Transport, who are administering the funds, that the funding would disappear – however, the funds are allocated to this project specifically. If this project was deferred beyond the Perth City Deal timeframe, then trying to get this body of work done in the next two and a half years, the Administration would need to discuss with the Department of Transport whether that funding lapses or can be moved to a different project potentially.

Councillor Gordon

- Q1 How was the weighting of the criteria was determined?
- A General Manager Infrastructure and Operations

 As standard procurement practice, the City's major capital works projects typically have these weightings.
