#### 4.1 Deputy Lord Mayor Bain's Resignation Letter from the Role of Deputy Lord Mayor

The Lord Mayor announced that on the 6<sup>th</sup> of October 2022, Deputy Lord Mayor Di Bain tendered her resignation from the role of Deputy Lord Mayor. Councillor Bain will continue in her role as a Councillor however Council will be required to elect a new Deputy Lord Mayor at next week's Ordinary Meeting.

#### 4.2 Recent City Figures

The Lord Mayor referred to the Property Council's office occupancy statistics for the month of September, specifically the City's peak weekly figure was at 84% which was the highest in the country. The City continues to lead the way in post COVID recovery with an overall figure of 76%. The Lord Mayor also advised of the Tourism and Transport Forum's data which showed Perth CBD outperforming all other capital cities in terms of workers and visitors returning to the CBD. Perth is at 85% of pre-COVID levels.

The Lord announced that this weekend Telethon would return to the CBD after a number of years, particularly the Family Fun Day which will take place in and around the RAC Arena. The Lord Mayor encouraged everybody to bring their families along to what will be a brilliant day in the City with lots of free activities.
