4. Announcements by the Lord Mayor

5:04pm Cr Bain entered the meeting during Item 4.

4.1 Street Name Change – Nelson Avenue to Sailani Avenue

The Lord Mayor thanked and acknowledged his fellow Councillors for their support in renaming Nelson Avenue, East Perth to Sailani Avenue when the request came before Council recently.

The Lord Mayor stated that the request had been facilitated by the Department of Foreign Affairs and Trade (DFAT) which had come from the Indian Prime Minister Narenda Modi directly to the Australian Prime Minister Anthony Albanese, which then made its way to the City of Perth.

The Lord Mayor shared the story of Private Sailani who was born in India and arrived in Geraldton in 1895, Private Sailani was 22 at that time and worked as a labourer before enlisting with the Australian Imperial Forces during World War One in 1916, he was one of twelve known Indian ANZAC's. Private Sailani sailed out from Fremantle on 6 June 1916 and was sadly killed in Action in France on 1 June 1917 and his remains were buried in Belgium.

The Lord Mayor detailed that the Prime Minister of India requested the name change after he had become acquainted with the story as not only did it represent those people of Indian origin or Indian descent who came to Australia for a new life and great opportunities, but it also demonstrated their commitment to their new homeland in answering the call of duty.

The Lord Mayor stated that it was his pleasure on behalf of the City of Perth Council alongside representatives from the WA State Government and members of the Indian Community to preside as the name of Nelson Avenue was changed to Sailani Avenue.

The Lord Mayor clarified that the reason that road was chosen was due to its close proximity to the Western Australian Cricket Ground (WACA) where Australian and Indian people have shared their common love of cricket and have created many great memories together.

The Lord Mayor advised that the name Nelson, in honour of Admiral Horatio Nelson the British Naval Commander, had been applied to both Nelson Crescent and Nelson Avenue, and given that there was still a Nelson to stay in vogue in operation down near the WACA, the Nelson Avenue option had been chosen.

The Lord Mayor described the ceremony as fitting and a wonderful thing for the City of Perth to have been able to help facilitate and that he was proud of the decision of Council.
