#### ATTACHMENT 4 - In-Kind Clarification

#### Item 12.1 – Event Sponsorship 2023/24 – Round 1

#### What is in-kind

- 'in-kind support' is defined in Outgoing Sponsorship Policy 4.3 "where the City provides the value of its resources, goods or services to eligible parties instead of cash as part of a sponsorship or grant. <u>In-kind support will be attributed a monetary value and considered within the totality</u> of funds provided by the City to the eligible party."
- In-kind support is attributed a monetary value in line with agreed City fees and charges.
- Awarding any in-kind reduces the available budget in the same fashion as cash.

### Why in-kind hasn't been recommended in Event Sponsorship

- Sponsorship applications are received months in advance of the event date and the in-kind requests are estimations of varying degree of accuracy (see attachment) that can change.
- It is common for event plans to change impacting the City fees and charges. If in-kind has been awarded and then plans change reducing the City fees and charges, this funding will go to end of year surplus. Due to the timing of round two, there will be no ability to reallocate. Awarding cash sponsorships provides certainty over the funding allocations.
- Awarding cash ensures the applicant receives the full value of the sponsorship in the instance that an in-kind request is overestimated.
- Event Sponsorship Round 2 will have a very tight budget. Giving additional support through in-kind will reduce the budget further.
- The panel have determined the overall recommended value to be awarded based on their evaluation of the event against the program criteria.

  These recommended cash amounts can be used to reimburse for in-kind elements.

#### ATTACHMENT 6 - In-kind Clarification

### Item 12.1 – Event Sponsorship 2023/24 – Round 1

#### What is in-kind

- 'in-kind support' is defined in Outgoing Sponsorship Policy 4.3 "where the City provides the value of its resources, goods or services to eligible parties instead of cash as part of a sponsorship or grant. <u>In-kind support will be attributed a monetary value and considered within the totality</u> of funds provided by the City to the eligible party."
- In-kind support is attributed a monetary value in line with agreed City fees and charges.
- Awarding any in-kind reduces the available budget in the same fashion as cash.

### Why in-kind hasn't been recommended in Event Sponsorship

- Sponsorship applications are received months in advance of the event date and the in-kind requests are estimations of varying degree of accuracy (see attachment) that can change.
- It is common for event plans to change impacting the City fees and charges. If in-kind has been awarded and then plans change reducing the City fees and charges, this funding will go to end of year surplus. Due to the timing of round two, there will be no ability to reallocate. Awarding cash sponsorships provides certainty over the funding allocations.
- Awarding cash ensures the applicant receives the full value of the sponsorship in the instance that an in-kind request is overestimated.
- Event Sponsorship Round 2 will have a very tight budget. Giving additional support through in-kind will reduce the budget further.
- The panel have determined the overall recommended value to be awarded based on their evaluation of the event against the program criteria.

  These recommended cash amounts can be used to reimburse for in-kind elements.
