4. Announcements by the Lord Mayor

4.1 Queens Gardens Carpark

The Lord Mayor stated that fiercely advocating for what is best for the City's ratepayers, business owners, operators and residents of the City of Perth has been his and the City's chief priority. He expressed that the City is proud of its record in this area.

The Lord Mayor advised that the Council is united in seeking a fair deal on behalf of its ratepayers for the Queens Gardens Carpark, valued at \$40M.

The Lord Mayor informed the meeting that State Government had proposed no financial compensation and no land swap. He stated that the Education Minister wrote to him on 21 November 2023 stating that "the State's offer is to purchase those two parcels of land at fair market valuation." The Lord Mayor advised that the valuation of \$40M was the State Government's, not the City's.

The Lord Mayor stated that the City is in favour of a primary school in East Perth and that it would benefit the community.

4.2 Safe Night Space for Women

The Lord Mayor advised that tonight the Council would consider the proposed Safe Night Space for Women and urged Council to approach the item in a measured and balanced way. He advised that what Council would be discussing is a planning decision and expressed that Council should take that into consideration.

The Lord Mayor reminded the meeting that when the City of Perth first identified that the Safe Night Space for Women, operated by RUAH at its location at the Rod Evans Centre, was likely to come to an end, the City went to great lengths to put that on people's radars early so that due consideration could be given to make suitable alternative arrangements.

The Lord Mayor outlined the timeline of events leading up to the closure of the Safe Nights Space at the Rod Evans Centre.

The Lord Mayor advised that he wrote to the Homelessness Minister John Carey on 5 September 2022. The letter stated, "I'm writing to advise that the City of Perth Council has re-affirmed our commitment to address homelessness by endorsing the City of Perth Homelessness Action Plan 2022-24. A key action of the plan is continuing the Safe Night Space for Women until May 2023. The Safe Night Space has proven successful In keeping women experiencing homelessness safe throughout the night and providing temporary respite from the dangers of sleeping rough." He quoted some figures. "On 3700 occasions support has been provided through the City of Perth Safe Night Space, which opened its doors in May 2021." The Lord Mayor quoted the final paragraph in his letter to the Homelessness Minister, "I'm seeking an opportunity to discuss the future of this valuable service given Council's funding commitment is only until May of 2023. Please contact my office to arrange a time to meet."

The Lord Mayor advised that Minister Carey responded, and that they met in November of 2022 at the City of Perth Committee meeting, with the Deputy Lord Mayor, CEO, Premier, Deputy Premier, Senior Ministers and Senior Staff. He advised that he asked the then Premier, Mark McGowan to consider the future funding of the Safe Night Space, given the City's funding for the two year commitment was due to come to an end in the next May.

The Lord Mayor read from the briefing note that was presented to that meeting. He advised that it talked about the background of the Safe Night Space for Women and how the City had responded to the identified lack of inner city emergency accommodation for women, and the City of Perth initiated a Safe Night Space for women at the Rod Evans Centre in East Perth. He stated that Council had committed to a two-year trial for the Safe Night Space, included funding of \$3.2M, and engaged RUAH to run the service seven days a week.

The Lord Mayor then read, "The Lord Mayor and the CEO met with Minister John Carey MLA on the 13th of October 2022 to discuss the future of the Safe Night Space for Women. The City has proposed that the operation of the Safe Night Space after May 2023 is funded by the State Government."

The Lord Mayor stated that he said in November 2022, to the Premier, Senior Ministers and Senior Staff in the room, "With Council's support, the City could provide State Government with the Rod Evans Centre for this purpose until Common Ground is built." He advised that this was the proposal that the City took forward in November 2022, and that they concluded with a recommendation, "The City of Perth requests that State Government fund the future use of the Rod Evans Centre as a site for the Department for Communities to operate a Safe Night Space for Women experiencing homelessness when the current funding ceases in May of 2023. Pending Council's support, the City of Perth proposes to provide the facility from May of 2023 up until the East Perth Common Ground facility is up and operational, currently estimated to be 2025."

The Lord Mayor advised that what was put to State Government at the time was rejected and some months later in 2023, the decision was taken as per what was always stated, that the two-year funded trial by the City of Perth Safe Night Space to close but with a six month extension to give everybody enough time to make suitable alternative arrangements.

The Lord Mayor expressed that he felt that on behalf of the City of Perth, it's important to reiterate those points because he felt that the issue of how much notice and how much detail was given had been lost in some of the conversations around the Safe Night Space.

The Lord Mayor stated that after the six month extension, the Safe Night Space closed in November of 2023 at the Rod Evans Centre. He stated that the reason for mentioning that closure is because the City had given an undertaking to return that facility to the community, as per the request of the community.

The Lord Mayor provided some details in the period prior to the closure of the Safe Night Space. He advised that from the 1st of October to the 30th of November, there were 24 incidents reported to the City of Perth and to Police; 1 assault, 1 damage, 11 disorderly reports or incidents, 5 that related to homelessness, 1 offender (unstipulated what the offence was), 1 requiring police action, 3 that were categorised as suspicious behaviour and 1 welfare check. He then stated that in the two months that followed the closure of the Safe Night Space, there was 1 incident reported, a burglary.

The Lord Mayor reiterated that when the City had decided to close the Safe Night Space for Women, it was doing that on behalf of the community, who had made it clear that that was what they wanted.

The Lord Mayor stated that when the City said that the Rod Evans Centre was going to be returned to community, to be used by community as per their request, that this was evidence that the City had done what it had said it was going to do.
