Background

A statutory authorisation exists where legislation contains an express power to appoint authorised persons and express powers and duties are vested in authorised persons. Sections 52 and 53 of the *Interpretation Act 1984* (WA) govern how such appointments are to be made under law.

Written laws applicable to local government may confer express powers or impose duties on the CEO or the Council (or a duly authorised delegate of either body) to appoint persons to be authorised to carry out certain functions and duties of the City of Perth as a local government.

In accordance with section 9.10 of the *Local Government Act 1995*, the CEO can appoint classes of persons as authorised persons for the purposes of written laws prescribed for the purposes of this section. Similar powers exist under other legislation. These have been documented in the table below in the 'Statutory Framework' section. Where it is permitted, the CEO (and the Council where relevant) have delegated their authority to General Managers of the City to exercise powers to appoint authorised persons. These delegations are set out on the City of Perth Register of Delegations and Authorisations.

Authorisation profiles have been developed that appoint specific positions, being 'classes of persons' (section 9.10(2), Local Government Act 1995) or 'offices' (section 53, Interpretation Act 1984) under specified local laws and legislation. These profiles, the classes of persons appointed under each, and the relevant authoriser (being the CEO or a General Manager who has been delegated the requisite authority) are detailed in the 'Profiles' section.
