## **Background**

Statutory authorisations, as specified under section 9.10 of the *Local Government Act 1995*, allow the CEO to appoint person(s) to be authorised for the purposes of one or more specified laws or specified provisions of one or more specified laws. In short, the CEO can permit employees to issue fines, penalties, permits and infringements under the specified legislation in their authorisation on behalf of the local government.

In accordance with section 9.10 of the *Local Government Act 1995*, the local government can appoint classes of persons to statutory authorisations. Consequently, the City has developed authorisation profiles that appoint specific positions (or classes of people) under legislation. These profiles, and the classes of people appointed under each, are detailed below.
