Introduction

A liveable, sustainable and prosperous city — this is the aspiration for Perth. Light speaks to everything we do in the community — safety, security, vibrancy and entertainment.

Feature Lighting sites within the City of Perth, such as Council House and Trafalgar Bridge have proven to be popular and simple tools to creating an engaging and vibrant after-hours experience for community members and visitors and serves as an important communication tool in promoting events and activities.

Objectives

The City recognizes the contribution feature lighting makes to help achieve our strategic pillars, Liveable, Sustainable and Prosperous. Lighting plays a key role in creating safe inviting public spaces and supports our vision of being the City of Light by working towards a vibrant and activated City.

The Feature Lighting guidelines are designed to provide clarity on the following objectives:

- enhance the city's visual appearance and sense of vitality through the lighting of identified buildings, structures and trees
- utilise the lighting to assist approved charitable and non-profit organisations in raising awareness of significant events or appeals
- utilise the lighting for significant City of Perth, State, National or International events

Eligibility

Applications will be accepted from charitable and non-profit organisations promoting a significant event or appeal that:

- Is recognised within the state of Western Australia.
- May be of significance to Perth and Western Australia.
- Is recognised nationally or internationally.

Applications will not be accepted that relate to commercial advertising purposes.

Applications will not be accepted from individuals for their own purposes.

General Conditions

- 1. Priority will be given to applicants that demonstrate any of the following criteria that:
 - Is a City of Perth initiative;
 - increases visitation to the City;
 - provides direct economic benefit to the City;
 - is of significance to Perth, as the capital city of Western Australia; is a national or international event which bring prestige to Perth; and
 - reflects the Western Australian culture and lifestyle.
- 2. City of Perth sites may be booked for a minimum of one night and a maximum of 2 nights per booking.
- 3. Bookings can be made up to one year in advance.
- 4. Bookings are on a first come, first served basis.
- 5. All days are available to book except for Australia Day or Anzac Day, during the Christmas period.
- 6. From time to time, bookings may overlap due to dual importance. In these circumstances the City aims to share the booking with both parties. Applicants will be given details of a joint booking and the implications if this should occur.
- 7. If a requested date or location is unavailable (already booked) applicants will be provided alternatives for selection.
- 8. The City has the discretion to accept or reject applications. This includes any request the City considers to be political, religious, or of a sensitive nature.
- 9. The City reserves the right to cancel a booking at any time.
